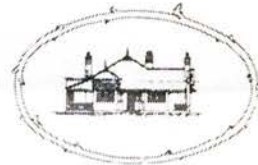

### *Beecroft Cheltenham History Group*

Hornsby Shire Council has awarded this year's Hornsby Heritage Award, Category C, to the Group's publication, *Giving the Gift of Reading: the Beecroft Children's Library 1942-1998*.

The award was presented on 5<sup>th</sup> April at 6.30 p.m. at Hornsby Council Chambers. The certificate was received by Suzanne Kelly on behalf of the group. Several members of the Library sub-group who researched the book over a period of five years were in attendance Suzanne Kelly (Convenor), Christie Wallace, Helen McDougall, Christine Austin and Emma Dortins.

For anyone associated with Beecroft or Cheltenham during this period the book will make very interesting reading. It describes many of the social and fundraising activities of the volunteers and is full of remembrances and comments from many of them.

The book is available at the Post Office and Denny Pharmacy in Beecroft Arcade and Kenwick Galleries in Hannah Street, priced at a very reasonable \$15. Any operating surplus will contribute to future publications by the Civic Trust's History Group.

## NEW SMOKE ALARM REQUIREMENTS FOR EXISTING BUILDINGS FROM 1 MAY 2006

**From 1 May 2006, all NSW residents must have at least one working smoke alarm installed on each level of their home. This includes owner occupied, rental properties, relocatable homes or any other residential building where people sleep.**

Smoke alarms are already mandatory for all new buildings and in some instances when buildings are being renovated.

Smoke alarms are life-saving devices that provide benefits for occupants. They detect smoke well before any sleeping occupant would and provide **critical seconds** to implement actions to save **life and property**. Smoke alarms are designed to detect fire smoke and emit a loud and distinctive sound to alert occupants of potential danger.

Smoke alarms have been mandatory in all dwellings in Victoria and South Australia since 1999, with 96% and 85-90% of dwellings respectively in those two states now having smoke alarms. In other states, smoke alarms have been mandatory only in new dwellings since 1995, under provisions of the Building Code of Australia. Evidence from the USA, where smoke alarms have been in wide use for 20 years, shows a reduction in house fire deaths of more than 50% in those homes where working smoke alarms are installed. The data available in Australia supports the USA figures. ## WASHING MACHINE REBATES



A rebate of \$150 is available to customers who purchase a new washing machine with a water efficiency rating of 4-star or 5A. The rebate offer commenced on 1 March 2006 and will run for 12 months.

5A/4-star water efficient washing machines save more

than 21,000 litres of water a year compared to older

machines. The rebate offer could help to save one million litres a day.

Eligible washing machines are clearly labelled and rebate application forms are available.

Please note that the rebate is for water efficiency rated washing machines with a 4-star or 5A water rating. This rebate does not apply to 4-star energy ratings. Full details available at <http://www.sydneywater.com.au/SavingWater/WashingMachineRebate/>

## COMMUNITY RECOGNITION AWARDS

In 2006, as part of the Hornsby Shire's 100 year centenary celebrations council is calling for nominations of individuals and organisations which deserve recognition for their dedication and hard work they contribute in our community.

The awards feature the following categories:

- Youth Recognition Award - For a Hornsby Shire resident 18 years or younger who has demonstrated a commitment to the community and welfare of others.
- Community Spirit - For a Hornsby Shire resident whose selfless and largely unacknowledged actions have improved the life of someone within the local community.
- Education and Mentoring - For a Hornsby Shire resident or individual who has displayed common sense, compassion and wisdom while teaching, coaching and mentoring others.
- Environment - For a Hornsby Shire resident or community group whose positive actions are contributing to building an environmentally sustainable shire.
- Cultural - For a Hornsby Shire resident or group who has made a significant contribution to the culture (eg arts, literature or performance)

- Community Service - For a Hornsby Shire community group, club or school that has made a noteworthy contribution to the local community. This could be through fundraising for a project, involvement in a community project or providing services to the community.
- Sporting Achievement Award - For a Hornsby Shire resident, local team, group or school that has either achieved in sport or has supported or fostered a sport or club.
- Historical - For a Hornsby Shire resident or group who has made a significant contribution to the conservation and promotion of local history.
- Emergency Services - For a Hornsby Shire resident or organisation which has volunteered their time to preserve the lives and property of residents of the shire.
