Man Charged after failing to quit:

About 8.20pm Sunday 26th January 2020, a 35 year old Condell Park man was refused service at the Bayview Hotel in Gladesville for being too intoxicated. The male was asked to leave the premises which he refused. After further prompting from staff he eventually left only to return a short time later where he stood at the entrance insulting security guards. When asked again to move away from the vicinity the male refused.

The male was arrested and searched. During the search Police located a clear resealable bag containing white powder, which Police will allege is Cocaine.

The male was issued with a Court Attendance Notice for Excluded person fail to leave premises when required, Excluded person remain in vicinity of licensed premises and Possess prohibited drug. He is to appear at the Burwood Local Court on 17th February 2020.

Woman Charged with Drink Driving:

About 5.08am Monday 20th January 2020, Police were patrolling the Hunters Hill area when they observed a vehicle drive through a red light. Police observed the car to be driving in an erratic manner which caused them to pull the vehicle over.

Police smelt alcohol on the driver who was a 20 year old female from North Ryde. The female was subjected to a breath test which returned a positive result. The female was arrested and taken to Ryde Police Station where she returned a positive reading of 0.146.

The female's licence was suspended and she was issued with a Court Attendance Notice for Drive with middle range PCA. The woman is to appear at the Burwood Local Court on 2nd March 2020.

Police reminding residents to lock their cars:

Recently there has been a number of Steal from Motor Vehicle incidents across the Ryde Police Area Command. Thieves have gained entry into vehicles and stolen various items. Thieves have been known to walk along and check to see if any vehicles are open before entering them. Ryde police wish to remind residents and vehicle owners to lock their vehicles and ensure all windows are closed.

Male Charged with furious driving of motor vehicle:

About 12:00pm on 23rd January 2020, a 41 year old Marsden Park man was driving his sedan on Victoria Road, Drummoyne when a minor collision occurred with a motorcycle which was travelling

in the same direction. The motorcycle has subsequently driven onto a median strip. The driver of the sedan has accelerated his vehicle towards the motorcycle and mounted the median strip, colliding with the rear of the motorcycle and throwing the victim from the motorcycle. The motorcycle became wedged under the front end of the sedan. The bike rider suffered some minor injuries as a result and was treated by ambulance at the scene. Police attended the location and placed the driver of the sedan under arrest. The driver was charged with drive furiously in motor vehicle causing bodily harm and negligent driving. The matter is now before the Burwood Local court on 24th February 2020.

Man charged with PCA

About 1:40am on Sunday 2 February 2020, police were at the intersection of Johnson St and Gladesville Rd Hunters Hill, waiting to make a right turn to travel east along Gladesville Rd. Police noticed a vehicle travelling east passing the intersection at speed. Police followed the vehicle and activated all lights and sirens for the vehicle to stop.

Police approached the vehicle and immediately could smell intoxicating liquor coming from the open window. Police spoke with the 23-year-old driver from Lane Cove. He was submitted to a breath test which returned a positive reading. He was arrested and taken to Ryde Police Station for a breath analysis.

The driver returned a reading of 0.113 and was issued with a Court Attendance Notice for Drive with Middle Range PCA. His licence was suspended by police and he is now due to appear in Burwood Local Court on 16 March 2020

Residents reminded to lock up their homes and vehicles.

Over the past few weeks there have been a several Break and Enters across Ryde's PAC, particularly in the Beecroft, Epping and Cheltenham areas. Thieves have gained entry through open windows, and in some instances the victims have been home.

Ryde LAC wish to remind residents to lock their windows, in particular if they live in a two story home and not to leave windows open downstairs, especially at night. It is also worth considering investing in window locks and alarm systems, to further enhance the security of your home.

There have also been several steal from motor vehicles during this period as well within the Ryde PAC. They have occurred at various times, throughout the day and night. The community is also reminded not to leave valuables in their vehicles, especially in view and lock their vehicles even if it is on their driveway!

The simple message is **LOCK IT** and leave **NO VALUABLES** in sight. Otherwise you could be the next victim, in what is a preventable crime.

Man charged with drug supply, trespass, ammunition possession - Ryde

A man has been charged with drug supply, trespassing and ammunition possession in Sydney's northwest yesterday.

About 1pm on Thursday 6 February 2020, police were called to a unit on Waterloo Road, Macquarie Park after the owner of the property complained that a tenant was refusing to leave after the lease term had expired.

Officers attached to Ryde Police Area Command attended the location and escorted the man from the premises.

The 32-year-old man allegedly became aggressive and police restrained him before searching his luggage.

Police will allege the search revealed several rounds of ammunition, bags containing white powder suspected to be steroids, multiple credit cards under various names, multiple interstate drivers' licences, motorbike registration plates and dyes.

The man was arrested and taken to Ryde Police Station.

Once there, the man complained of shoulder pain and he was attended to by NSW Ambulance paramedics.

About 6.40pm, the man allegedly attempted to escape custody and was stopped outside by a police officer who suffered minor injuries as a result of a struggle with the man.

The man was returned to the holding cell, where it is alleged he resisted a forensic procedure and assaulted a male constable.

The man was charged with trespass, possess ammunition without permit/licence, supply prohibited drug - steroids, supply prohibited drugs, escape police custody, assault police officer in execution of duty, intimidate police officer in execution of duty and resist or hinder police officer in the execution of duty.

He was refused bail to appear at Burwood Local Court on Friday 7 February 2020.

Shoplifter – Epping

About 3:00 pm Wednesday 5 February 2020, a 50-year-old man from St Kilda has entered a supermarket at Epping.

The man has then has selected a number of items and placed them in his bag, he has then left the store without paying for the items.

Once outside the store, the man was stopped by staff who had witnessed his actions. He was taken to the security office to await the arrival of police.

Police arrived a short time later and spoke with the man before issuing the man with a Court Attendance Notice for shoplifting. He is now due to appear in Burwood Local Court next month.
