Police Pursuit – Hunters Hill

About 10:45am on Wednesday 1 September 2021, Police attempted to stop a vehicle travelling along Ryde Road at Hunters Hill in relation to traffic offences. The vehicle appeared to slow down and indicate to pull over to the curb before suddenly accelerating and continuing to drive down Ryde Road.

Following a brief pursuit by police the vehicle has mounted a curb and collided with a timber fence surrounding the front yard of a residence in Hunters Hill. The vehicle has then continued through the yard before colliding with a brick wall. The two occupants were arrested and conveyed back to Ryde Police Station.

A 30-year-old man was charged with police pursuit, Drive whilst Disqualified, Drive unregistered vehicle, Breach Public Health Order and Breach Bail. A second male was issued with a Court Attendance Notice for breaching the public health orders and Possession of Knife in a Public Place. There was no damage to premises.

Execution of Search Warrant – North Epping

On Tuesday the 31 August 2021, a search warrant was executed by Ryde Detectives on an address at North Epping,

After Police gained entry to the premises, with the assistance of other Police resources, they located the occupants hiding within a shower recess within the house. The male and female were both arrested and conveyed back to Ryde Police Station where they declined the opportunity to be interviewed.

During the search Police located a large quantity of cannabis plants, globes, lampshades, mobile phones, gloves and other items.

A 38-year-old man and 39-year-old woman were charged with Cultivate Prohibited Drug - Large Commercial Quantity and Covid related offences. They were refused bail to appear in court.

Drug detection – North Epping

About 1:30am Sunday the 5 September 2021, Police attended a location in North Epping following a call-in relation to a suspicious vehicle.

Police spoke with the two male occupants who were seated inside the vehicle with the headlights on. After a brief conversation they conducted a search where they located a small amount of cannabis in the centre console.

An 18-year-old North Epping man was issued with Cannabis Caution and a fine for Breach of Public Health order.

Child Approach – Epping

About 1:50pm on Wednesday the 5 September 2021, a woman was with her 5-year-old daughter at a park in Epping. The woman has failed to notice her daughter has run off towards an older male to pat his dog.

The male has taken the child's hand and proceeded to walk away from the mother. The man let go of the child's hand when the mother called out to her and he kept walking.

Police conducted patrols of the park and the surrounding areas with nil success.

The man was described as being Asian, 70 – 80 years old, 170-180cm tall, and average build with short black coloured hair. He was wearing a black cap, black jackets and long black pants.

Drugs located in vehicle during proactive police patrols –North Ryde

About 9:00pm on Wednesday the 8th September 2021, Police were patrolling in North Ryde when they stopped a vehicle travelling along Kent Rd.

After a brief conversation Police conducted a search of the vehicle and located what police believed to be Cannabis wrapped in clingwrap, within the glove box of the vehicle.

The 28-year-old man from Epping was issued with a Cannabis Caution and an infringement notice for breach of the Public Health order.

Assault Police

On the evening on Saturday the 11th September 2021, Police were called to address in Putney where an alleged assault had taken place. On arrival Police confronted a 28-year-old female from a Dundas.

While being questioned by Police, regarding the assault, the female has become aggressive and attempted to run. A scuffle took place and during the altercation a female officer has been kicked in the mouth and jaw area.

Subsequently the female was arrested and charged for offences relating to Assault Police, Resist or hinder Police and not comply with Public Health Order.

Illegal Brothel

On Monday the 13th September, police attended an address in Pennant Hills in relation to an alleged brothel being run out of serviced apartments.

Police spoke to a male and female at the address where it was ascertained they were in breach of the public health order.

The male and female were issued with Breach of the Public Health order infringements and instructed to return to their home addresses.

Vehicle Fire Cherrybrook

About 17:30 on Monday the 13th September 2021, Police have responded to reports of a Volkswagen ute alight on New Line Road, Cherrybrook.

Police were met at the scene by NSW Fire and Rescue where the fire was extinguished a short time later.

It was established that an industrial Acetylene tank was the cause of the fire, however investigations are still ongoing. The Volkswagen ute was destroyed.

Drug Possession and Breaching Public Health Order – Putney

On Wednesday the 15th September 2021, Police were patrolling in the Putney area regarding offences relating to the Public Health Order and Operation Stay at Home.

A parked vehicle came under the notice of police and checks were conducted on the vehicle and owner. After a brief conversation the male Police conducted a search of the vehicle.

During the search they located a small amount of Cannabis in the front of the vehicle. A man from Ermington was issued with a Cannabis Caution and an infringement notice for Breach of the Public Health Order. The male was given a move on direction to return home.

Drug Seizure-Eastwood Police Station

About 7:00pm on Wednesday the 15th September 2021, a 26-year-old male attended Eastwood Police Station handing over a clear resealable bag containing green vegetable matter believed to be Cannabis.

The 26-year-old male advised police that the Cannabis was of 'Poor Quality' and wanted police to know.

The male was issued with a Cannabis Caution for his efforts.

Drug Seizure North Ryde

About 1:40pm on Wednesday the 15th September 2021, police were patrolling around North Ryde when they sighted a vehicle parked in a peculiar location.

Police spoke with the driver who was seated in the driver's seat. After a brief conversation a search of the vehicle was conducted where police located a small amount of Cannabis.

The 44-year-old man from Gladesville was issued with a Cannabis caution and issued an infringement notice for failing to comply with the current Public Health Order.

Vehicle Stop, Cash seized

About 4:30pm on Friday the 17th September 2021, police were conducting High Visibility Patrols in the (street) Ryde area when a vehicle was stopped due to its manner of driving.

Police spoke with the 21-year-old male from Meadowbank and as a result, police subsequently searched the vehicle.

Police located a large amount of cash inside the vehicle. Police seized the money and further investigation are continuing.

Assault-West Ryde

On Monday the 20th September 2021, Police were called to a Service Station on Victoria Road, West Ryde in relation to an assault over the use of fuel pump. The victim was threatened by a male with a metal pole.

Police arrived a short time later and spoke with the male. As a result the weapon was seized and the 44-year-old man from Mount Vernon was charged with multiple offences.

He will appear in Hornsby Court on the 13th of October 2021.
